## SECTION A - RULES OF THE PROMOTION

### 1. GENERAL

- 1.1. **50% Deposit Bonus** is a special promotion initial capital that is given to TradingPro International Ltd clients who have fulfilled the conditions of the promo.
- 1.2. The minimum deposit to join is Deposit Bonus is USD 100 and the maximum is USD 1000.
- 1.3. Deposit Bonus is only for an MT4 account with USD based currency: **Scalpx account ONLY..**
- 1.4. Deposit Bonus is not available to the clients, who took part in Deposit Bonus promotions earlier.
- 1.5. To receive Welcome Bonus, you must fulfill the following conditions:
  - 1.5.1. Pass the personal verification, which consists of two required steps:
    - 1.5.1.1. Identify card verification/passport verification and address verification.
    - 1.5.1.2. Verify your mobile phone number.
    - 1.5.1.3. Open **Scalpx Account (50% Bonus)**
- 1.6. Each client can receive a Welcome Bonus only once.
- 1.7. The offer is valid for clients from the **Philippines and Thailand only.**

## **2. RECEIVING BONUS**

- 2.1. Bonus will be received by clients automatically when all requirements are fulfilled.
- 2.2. The Bonus will be credited instantly.
- 2.3. All eligible clients are permitted to hold only one (1) Deposit Bonus account per one Unique IP address and for one device. Multiple registrations from the same IP address and same device are not permitted nor multiple deposit bonus account registers with the same details.
- 2.4. Any indication or suspicion, in the Company's reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage connected to a trading bonus or any other forms of deceitful or fraudulent activity, will nullify all previous trading.
- 2.5. In these circumstances, TradingPro reserves the right at its reasonable discretion to close/suspend (either temporarily or permanently) all such Eligible Client's real trading Accounts with TradingPro, cancel all orders and deny all profits of such participants.
- 2.6. Company shall not be liable for any consequences of the trading bonus cancellation, including, but not limited to, order(s) closure by Stop Out.

## **3. BONUS WORKS**

- 3.1. Clients' personal funds and bonuses can both be utilized without limits in trading. Bonus cash may be accessed during the "drawdown" in this situation. In other words, they won't be written off from the account until Stop Out occurs if the equity in the account is less than the deposit bonus funds.

- 3.2. Without any restrictions, the client can withdraw his/her own money from the account along with any profits, but the bonus will be wiped off.

**EXAMPLE:** You made a \$100 deposit into your account and were given a 50% deposit bonus. Your profit after trading is \$100. The amount that may be withdrawn will be made up of your profit of \$100, your own money of \$100, and 50% will be written off.

#### 4. BONUS CANCELATION AND WRITING OFF

- 4.1. Once Stop Out takes place, a bonus is written off from the client's account.
- 4.2. Once clients make any amount of withdrawal, bonus will be written off from the client's trading account.
- 4.3. The client has the right to reject the received Deposit Bonus at any moment.
- 4.4. Please note that TradingPro Ltd reserves the right to, at any time and without any reason, refuse to grant the bonus or write off the previously issued 50% Deposit Bonus from the account, as well as revoke (cancel) all transactions that have been made with the use of the bonus funds. This condition is considered accepted (agreed with and accepted) by the client starting from the moment of depositing the "Deposit Bonus" to their trading account.
